**REIMBURSEMENT:** When a student is hired on an assistantship by a unit outside of the student's academic college, the student will still receive a waiver but some programs require reimbursement from the hiring unit.

**BASE RATE WAIVERS:** Multiple base rate waivers cannot be combined to waive more than base rate. Some programs only grant a base rate waiver. That waiver will waive only the graduate resident portion of the tuition assessment.
